Content

The great territorial transformations which have affected Europe in the past fifty years, joined to the vast urbanization of entire regions, determined strong impacts on the heritage and the landscapes, with different results according to various protection legislations and research traditions.

It appears, therefore, compulsory to define common strategies, especially in respect to great fostered infrastructure project works, involving Member States territories, in the light of the imminent enlargement.

The goal is to involve on the definition of uniform conservation strategies the new-entering Member States, as well as, in the light of cooperation policies, Mediterranean, Near and Middle East Countries.

The sum of single national strategies for the conservation of the cultural heritage does not, in fact, represent, as such, a European policy on the matter, as opposed to the status of "common resource, for the conservation, management and planning of which we need to co-operate" (European

Landscape Convention, October 20 2000), applied to landscape quality and diversity.

It is, therefore, of the utmost importance to harmonise preventive, both cognitive and conservative, strategies in the spirit of the Valletta Convention, 1992.

Memory preservation in the information society, with particular attention to new technologies.

Territorial information systems as instruments of memory preservation, conservation and management for the development of the European territory and heritage.

- Variety of sources, with particular reference to historical cartography;
- Technological components, exchange formats, techniques;
- Risk monitoring ;

The initiative aims at reaching European added value in its coherence to the Work Plan, in its undoubted visibility, due to the effective impacts it could determine on national territorial planning and management policies, as in the development of new strategies to fasten enlargement.

With this Seminar, organized within the Italian Presidency, the Italian Ministry for Cultural Heritage and Activities aims at the creation of a European research working group, composed of national representatives, referent in the field of information systems for the knowledge and conservation of the European territory and cultural heritage.

Proposal for the definition of minimum average standards, required by single national Territorial information Systems, for the management, enhancement and promotion of cultural heritage of European significance.
